CREDIT AGREEMENT

In consideration of the extension of credit by Hamburg Brothers, the undersigned ("Purchaser") agrees that all purchases made by the Purchaser from Hamburg Brothers are subject to the following terms and conditions.

TERMS:

Terms and payment due date shall be as stated on the face of the invoice. All invoices must be paid promptly in accordance with those terms. A finance charge of 18% per annum (1.5% per month) shall be assessed on past due items. If terms are subject to a cash discount, payment must be received by Hamburg Brothers within the cash discount period.

RETURN CHECK POLICY:

Purchaser shall pay to Hamburg Brothers a service fee of \$25 each for all checks returned by Purchaser's bank. This fee may be increased to match the prevailing fee charged by the banking industry.

COLLECTION COSTS:

Purchaser agrees to pay any collection costs incurred to collect the account balance, including reasonable attorney's fees and court costs.

CHANGE OF OWNERSHIP:

Purchaser shall immediately notify Hamburg Brothers by certified mail of any change in ownership of the purchaser.

PURCHASER'S WARRANTY:

Purchaser warrants to Hamburg Brothers that all information submitted for the purpose of obtaining credit is true, correct and complete in all material respects. Purchaser further authorizes Hamburg Brothers to investigate all credit references listed in the Credit Application.
